Sustainability Tips

- Ask for products that are energy and water efficient, less toxic, more durable, and contain recycled content.
- ✓ Anything that plugs in should be registered with Energy Star.
- ✓ If it uses water, check for the US EPA WaterSense label.
- ✓ Fight pests without pesticides: Use Integrated Pest Management.
- ✓ Green your fleet: alternative fuel vehicles, charging/fueling stations, recycled motor oils/refined antifreeze, and non-lead wheel weights.
- ✓ Build and use clean, renewable energy.
- ✓ Reduce, Reuse, Recycle!

The following are some of the third-party environmental certifications that support environmentally preferable building operations products and services:

- Biodegradable Products Institute compostable bags, food service ware
- Consortium for Energy Efficiency LED and fluorescent tube lamps
- Cradle to Cradle building materials, construction adhesives, paint
- DesignLights Consortium LED lighting equipment
- Energy Star appliances, HVAC, lighting equipment, roofing materials, etc.
- Forest Stewardship Council wood and paper products
- Green Seal cleaners, floor polish/strippers, hand soaps, janitorial paper products, paints
- Master Painters Institute (MPI) Green Performance Standard paints and coatings
- NEMA Premium Efficiency motors, ballasts
- SCS Indoor Advantage Gold building materials, furniture
- SCS FloorScore carpet, flooring, flooring adhesives, underlayment
- UL GREENGUARD Gold adhesives, flooring, insulation, sealants, etc.
- UL EcoLogo cleaners, deodorizers, hand soaps/sanitizers, floor polish/strippers, janitorial paper
- USDA Biobased lubricants, building materials
- **US EPA Safer Choice** cleaners, hand soaps, deicers, furniture polish, dish detergents, etc.
- US EPA WaterSense water-efficient fixtures, toilets, irrigation equipment
